- Home share fee for service rates: CLBC is still working very hard at get things in order to present the new rates for fee for service to our agency for Home Share Providers. Community Connections hasn't yet received confirmation from CLBC to implement the new rates...but not to worry! As CLBC has indicated back in the spring of this year, the new rates will be retroactive to April 1st, 2019. Once the approval has been given from CLBC to make the changes to the new rates, Home Share Providers will be reimbursed for all applicable months. If you have any questions regarding the new rates please talk to your Home Share Coordinator or James Croston, Service Coordinator.
- Recently all Home Share Providers have been emailed a link to the Community Connections online Policy Manual along with the password to access it. In the past, Community Connections provided a hard copy of the policies and forms in the Home Share Manual and issued the manual every 3 years. Community Connections has decided that a better way to provide Home Share Providers with the most up to date policies was online for quick reference. If any Home Share Provider didn't receive the link and password please let your Home Share Coordinator know or check your junk mail inbox in case it landed in there.
- Satisfaction Surveys: Surveys for both Home Share Providers and Person receiving services were emailed out this Spring. Thank you for everyone who participated in the surveys. The information being collected from the surveys serves as a way for us to see how we're doing as a service provider and what may need to change in the future to provide better Home Share Services. We are hoping to share our findings with everyone this Fall. Your opinion and feedback matters and means the world to us. #### Reporting.....

Whether going away for an extended trip, experiencing changes to your living situation, changing your contact information, or experiencing an incident resulting in a CIR or Non-CIR. It is **IMPORTANT** to ensure you notify your home share coordinator or agency right away, so they may update the information and provide direction/support to you.

Remember when it comes to reporting CIR and Non-CIR, there are required timelines to keep in mind.

In the case of **Urgent Incidents** (any allegation of abuse or neglect, unexpected death), Employees and subcontractors are to notify their service coordinator or home share coordinator **IMMEDIATELY**.

For all other incidents (CIR or Non-CIR) you have up to 24 hours to submit and report the incident.

Also, ensure you contact your Home Share Coordinator as soon as possible to inform them of what's happening. It is imperative that Community Connections Support Services and CLBC know where everyone is at all times to ensure everyone is safe.

This year, Community Connections Support Services Home Share Coordinators are utilizing a tool which can be downloaded for free off of the App Store for smart phones. The app is called 'Voyent Alert'. You can input a location or locations into the app to provide you current information on all alerts and evacuations orders in the areas. It's a great tool to have and one you may want to look into for yourselves to keep you updated. Check it out!
